**REQUEST FOR**

receiving, for the academic year 202\_\_/202\_\_, the scholarship for **the 2<sup>nd</sup> / 3<sup>rd</sup> year of the above-mentioned Ph.D. course:**

For this purpose, pursuant to art. 46 and 47 of Presidential Decree 445/2000, aware that false declarations are punished pursuant to the criminal code and special laws on the subject, according to the provisions of art. 76 of Presidential Decree 445/2000

**DECLARES:**

- a. to have never received a scholarship for a Ph.D. course (art. 6, c. 2, L. 30/11/1989 n. 398);
- b. to be aware that the present Ph.D. scholarship cannot be combined with other scholarships of any kind, except for those conferred from national or international institutions useful to integrate, with a period spent abroad, the training or research activities of grant holders;
- c. to be aware that the scholarship is exempt from IRPEF, pursuant to article 4 Law n. 476/1984; also, the scholarship is subject to the social security laws, especially to article 2, paragraphs 26 and following, Law n. 335/1995;
- d. to be aware of the obligation to immediately communicate the possible acquisition of the status of *public employee* at any time it takes place;
- e. to be aware that the request of *special live for study reasons* as a public employee should be related to the duration of the Ph.D. course (Law n. 476/984);
- f. to be aware that the candidate has to withdraw from the Ph.D. course if no request for special live for study reasons is submitted or if the membership organization won't allow the special live;
- g. to be aware that if the Ph.D. student intends to undertake work activities, he/she must communicate this decision to the Ph.D. Coordinator, so that the Academic Board could verify the compatibility of the employment with the activities of the Ph.D. course (teaching and research activities);  
after receiving a positive opinion of the Supervisor, the Academic board can authorize the exercise of the working activity;

- h. to be aware that the Ph.D. student cannot work more than 528 hours in a year, otherwise he/she will lose the scholarship (as stated in article 15, paragraph 16 of the Regulations for Ph.D. courses);
- i. to be aware that the earning of a wage higher than € 16.000,00 (gross amount) implicated the loss of the scholarship;
- j. to undertake to promptly declare the circumstances referred to the points i) and j), as stated in the Regulation for Ph.D. courses.
